Request for Trading Halt

Pursuant to ASX Listing Rule 17.1, DUG Technology Ltd (ASX: DUG) (the “Company”) requests an immediate trading halt be granted by ASX in respect of its ordinary shares from the commencement of trading today, Wednesday 16 October 2024.
